

On the basis of recommendations of Principal, Government Polytechnic Reasi and in view of detailed estimate technically checked by Executive Engineer, PWD (R&B) Division, Reasi, Administrative Approval is hereby accorded for execution of the work namely "**Construction of Cafeteria at Govt. Polytechnic Reasi**" at the estimated cost of ₹ **30.00 lakhs** approved under Languishing Projects to be funded through Jammu & Kashmir Infrastructure Development Corporation (JKIDFC) Ltd:

The Accord of Administrative approval shall be subject to the following conditions:-

1. Before incurring expenditure over any Languishing Projects out of funds provided through JKIDFC Ltd., the concerned executing agencies are requested to ensure the completion of basic requisite formalities and issue a certificate to the same as shown in Annexure "A" to Govt. order No. 495- FD of 2018 dated:- 20-11-2018 .
2. The instructions issued by the Government from time to time relating to construction of works through JKIDFC shall be implemented in letter & spirit.
3. That the work or part of it has not been executed earlier under any scheme nor has same been proposed for execution under any other program/scheme so as to ensure that there is no multi-source funding or over lapping of schemes for the same work.
4. The work shall be allotted for execution as per standing instructions of the Government issued from time to time.
5. The Technical sanction shall be got accorded from the Competent Authority
6. The purchases, if any shall be made as per standing instructions of the Government taking into account the Austerity measures invoked by the Government from time to time.
7. The payments shall be made after proper verification of components of work and the cost of work shall be restricted to the actual work done & not beyond AA cost.
8. The Revision of Cost shall not be entertained.
9. The pre execution/post execution photographs duly signed by the Head of Institution and Executing Agency shall be kept for record and reference.
